Please keep your individualized bid card program accessible for the duration of the evening, and use the number listed on the back of your card for all bids.

Live Auction • To bid on the live auction, hold your individual bid card high in the air until the auctioneer acknowledges your bid. A declaration of sale by the auctioneer will constitute a contract for the purchase of the live auction item by the successful bidder. The auctioneer is responsible for the conduct of the auction. If there is a dispute, the decision of the auctioneer is final. A volunteer will collect your contact and payment details right away in exchange for your prize item.

Gift of Hope • To pledge during the Gift of Hope appeal, hold your bid card high in the air until the auctioneer acknowledges your pledge. A volunteer will collect your payment once the Gift of Hope concludes, using a hard copy donation form. Please provide your full mailing address, email address and payment details. These details are mandatory for a charitable tax receipt. You are also free to make a donation via our online Givergy platform using the tablets on your table. However, this function will only be available before and after the Gift of Hope appeal, not during.

Silent Auction • All auction items must be removed from the venue the same evening, unless other arrangements have been made. If other arrangements are confirmed, the successful bidder is responsible for picking up the item from the Looking Glass Foundation office after the event or incurring additional delivery costs.

Title to the auction item remains with the Foundation until the full payment for purchases has cleared. A online receipt must be presented before the removal of any purchased item.

Tax Receipting • In accordance with Canada Revenue Agency regulations, if the auction purchase price exceeds the item's fair market value by 25% or more, the purchaser is eligible for a tax receipt for the portion of the auction purchase price exceeding the item's fair market value. Please contact the Foundation directly at sarahclark@ lookingglassbc.com if you would like to request a tax receipt under these conditions. Please note: any auction items listed with a "priceless" value are not eligible for tax receipts.
